5. Rules To Regulate Cane And Beet Raw Sugar Contracts CIF Free Out And Cost & Freight Free Out – RULE 106 International Scale

Explanatory Note: - Introduction of new Rule 106 INTERNATIONAL SCALE for vessels presenting for loading up to and including 29 February 2016 and for all vessels presenting for loading from and including 1 March 2016.

6. Rules To Regulate Cane And Beet Raw Sugar Contracts FOB & Stowed And FAS – RULE 206 International Scale

Remove existing pages 1 and 2 and replace with Rules To Regulate Cane And Beet Raw Sugar Contracts FOB & Stowed And FAS effective from 1 June 2014.

Explanatory Note: - Introduction of new Rule 206 INTERNATIONAL SCALE for vessels presenting for loading up to and including 29 February 2016 and for all vessels presenting for loading from and including 1 March 2016.

7. Rules To Regulate Supervision, Weighing, Tarring And Sampling Etc. – Rule 310 (c) Samples

Remove existing pages 5 and 6 and replace with Rules To Regulate Supervision, Weighing, Tarring And Sampling Etc. effective from 1 June 2014.

Explanatory Note: - Rule 310 ( c) is amended to replace samples representing one thousand tonnes to two thousand tonnes.
